## Relationship Development Intervention® Service Contract

This contract is between Dynamic Connections, LLC (Deb Berrang, M.Ed.) and

This is an hourly contract is for Relationship Development Intervention® with Dynamic Connections, LLC, and includes the following services and benefits:

- Initial Intake Meeting - Family receives, fills out and returns intake paperwork, which is reviewed by consultant. Family provides initial 5-10 minute baseline video of each participating parent interacting with each child. Consultant provides overview of RDI®, the RDI operating system (RDios), and Q & A time for parents. Parents are responsible for returning completed paperwork to consultant at least 3 days before Individual Family Needs Meeting.
- Individual Family Needs Meeting - Consultant will have reviewed all paperwork. As a team we will discuss priorities, concerns, needs and preferred family timeline. If needed, schedule Baseline RDA1.
- Parent training and coaching (consultations) an average of 2 times a month - office, skype, phone or home sessions.
- Consultant will review and provide written feedback on all video clips submitted with written parent evaluative reflections via the RDI-LS®.
- Baseline and/or complete Relationship Development Assessment (RDA®) usually within 6 months, with components of assessment determined according to current RDI® Program protocol.
- Access to Partnering with Parents Support Meetings and Family Outings
- Family provided with copy of *The RDI Book*.

- Services are billed on an hourly basis at a rate of \$90.00 an hour. Billed services include session time, preparation and follow-up time, and video review time. Assessments are billed on an hourly basis for both assessment and report/plan development. For home sessions greater than 10 miles distant from Consultant's office, travel time is charged at the rate of \$25.00 an hour. If an overnight hotel stay is necessary, any families being visited will split the cost of the hotel. (Every attempt is made to find a reasonably priced hotel accommodation.) Family will be billed the last day of each month, with payment expected by the 15th of the next month. Families may request PayPal invoice if they prefer to pay by credit card.
- The professional that will provide the assessment and consultation services is an RDI® Program Certified Consultant.
- Clients receiving distance consultation are responsible for being prepared to receive the consultant's call at their scheduled appointment time.
- To participate in a formal RDI® program, I understand my family must subscribe to the RDI® Learning System. The subscription payment for the RDI-LS® is paid separately from this contract, paid directly to the Connections Center, which is not affiliated with Dynamic Connections, LLC. (*Current subscription rate is \$50/month*)
